NWA Leadership Conference Scholarship Application (2020)



Purpose:

The Annual NWA Leadership Conference allows WIC staff and stakeholders around the nation to join in learning how to advocate, and provides the opportunity to advocate for the WIC Program in Washington D.C.

The conference is split up into two parts:

- 1. The first part features sessions about federal and state WIC policy, local WIC leadership, WIC research, WIC food packages, immigrants' access to WIC, creating strong WIC messages, and other exciting topics.
- 2. The second part includes an "Advocacy Day" where we will schedule to meet with our Senators and Representatives on Capitol Hill to educate them on the role WIC plays, bringing the message from a local perspective.

The WWA will provide at minimum three \$1,000 scholarships to help cover a portion of the costs for the conference (expenses may accumulate around \$1,700). The WWA board also pays for two full board member scholarships to attend this conference, so those of us from Wisconsin can connect and participate together.

- ✓ Submit an application (below) which includes an approval signature from your supervisor and personal statement.
- ✓ You agree to be an active member of the 2020 Advocacy Committee.
- ✓ You agree to attend the full conference which includes completing scheduled Capitol Hill visits with your Congressional Delegates until 5:00 PM on the last day of the conference. This means that you will need to schedule your flight accordingly and perhaps plan to stay until Wednesday morning.
- ✓ Within 30 days following the conference, you will submit a WWA expense request form including receipts of all expenses.
