WWA BOARD MEMBERS ADVOCATE FOR WIC WAIVER EXTENSIONS

THE SOCIAL MEDIA CAMPAIGN THAT SPARKED SUPPORT

With uncertainty looming as WIC waivers neared their expiration date in September, NWA and WWA teamed up to show their support of an extension that would continue to provide the ease of WIC services, while keeping our participants and staff safe. The hashtag #wicwaiverswork began trending nationally, as WIC staff and partner organizations advocated on social media to urge USDA to extend these waivers.

On September 21st, those waivers were extended by USDA until 30 days after the end of the national emergency declaration, providing WIC clinics the flexibility to plan for reopening. WIC participants can continue to stay home to keep their families safe, and still receive their WIC benefits. "WIC waivers work. By reducing the risk of exposure to COVID-19 and creating more options for participants, WIC has not only continued to support the nutrition needs of participating families, but also has reached hundreds of thousands of newly eligible families due to changing economic circumstances" says Rev. Douglas Greenaway. We are grateful to NWA for initiating this opportunity to advocate!

PREGNANT WORKERS FAIRNESS ACT PASSES IN THE HOUSE

NWA AND WWA ADVOCATE TOGETHER FOR THIS IMPORTANT LEGISLATION

At the request of NWA, two of our board members flew out to Washington D.C. in February to meet with legislators and advocate for expecting mothers. The Pregnant Workers Fairness Act (PWFA) would establish reasonable accommodations for pregnant women, and protect them from retaliation in the workplace due to their pregnancy or childbirth.

On September 17th, the House voted to pass the PWFA, which is now awaiting approval in the Senate. "The passing of this legislation in the House is extremely validating, not only to our efforts, but also to pregnant moms across the country. The passing means I see you, I value you, and you matter as both a pregnant woman and a working person and the fact that you are doing both is incredible and something that should be supported, not punished," says Kara Kerrigan. The work is not finished, but this is a very exciting win for all women nationwide.
