FULL FUNDING FOR WIC!

The WIC Community and its many partners are celebrating after Congress passed a bipartisan budget bill that secured full WIC funding for 2024, avoiding the threat of waiting lists and ensuring any family that needs WIC services will have access to them. This funding secures the increased fruit and vegetable benefit that so many of our families have enjoyed.

Thank you to all who participated in advocacy efforts over the past months. Any contact you made with lawmakers or communication with partners about WIC has an impact.

What is next?

- The Final Food Rule is expected to be released soon! USDA received more than 15,000 public comments on the proposed food rule. Once the final rule is released, states will go to work to apply those rules to their food lists. Watch for more information on this in the coming weeks.
- The 2025 Budget was released. The budget shows a continued commitment to WIC and includes additional funding. Watch for upcoming opportunities to advocate for WIC in the FY25 budget process.

THE 2024 NWA POLICY CONFERENCE

The 2024 NWA Virtual Policy Conference was held February 20-21 focused on celebrating the 50 years of WI. Sessions included sharing reflections of how WIC came to be and how we continue to grow the WIC impact.

A theme of the conference was WIC continuing to be supported by sound science and the importance of education to the public and policy makers on impact of WIC in communities.

As a scholarship recipient from WWA, I was honored to be able to learn and be inspired by those that set the foundation of WIC.

Through this conference I continue to feel confident as a strong advocate for WIC and the families we serve.

The conference commenced with a day to meet with Wisconsin legislators. WWA members connected with Congressional staffers of both Senators and 6 of the 8 Wisconsin Representatives.

The main messages shared were:

1) Fully Funding WIC

2) Finalizing the science-based revisions to the WIC food package and


3) Securing the flexibilities of hybrid WIC Services through the Modernize WIC Act.
